- Read though this entire document before proceeding.
- Presentations must comply with the Conference Code of Conduct or the Session Chair may terminate it without recourse.
- All submissions must be made via the online portal.
- Ensure ALL authors/presenters are aware of, and agree with, the abstract details as well as the submission terms and conditions.

# **Important Information**

# **PRESENTATION TYPE**

For each abstract, you must indicate the presentation format for which it is being submitted from the following options.

- 1. **Oral presentation** an oral presentation, using PowerPoint slides, presented by one nominated author. Presentations will be 15 minutes, consisting of 12 minutes presentation and 3 minutes of questions from the audience.
- 2. **Poster** authors will have the opportunity to have their Poster in the Exhibition Hall for the entire duration of the Conference for delegates to view.
- 3. Either oral or poster





### **ABSTRACT SUBMISSION CONTENT GUIDELINES**

To assist the committee in deciding if your abstract submission is selected for the final conference program, please adhere to the following guidelines:

- Submissions should be no longer than 400 words (excluding title and other contact details).
- Abstracts and presentations must comply with the code of conduct.
- All abstracts must be submitted in English.

#### **NOTIFICATION OF ACCEPTANCE**

People who have submitted an abstract will be notified of acceptance or otherwise via email by **Tuesday 30 April 2024.** The decision of abstract acceptance is at the discretion of the committee.

#### **REGISTRATION**

Accepted authors are required to register for the conference by **Thursday 4 July 2024.** Additional information and instructions will be sent to accepted authors. If you do not register by the due date, your presentation may be withdrawn from the program.

#### **IMPORTANT INFORMATION**

- Please immediately notify the Committee if you are unable to present or if there is a change the presenting author.
- The author is responsible for the accuracy of the abstract.
- Do not include references in your abstract.
- All presenters of accepted submissions are expected to register and pay to access the Conference.
- The acceptance of an abstract does not imply provision of travel, accommodation or registration for the Conference, nor any other costs associated with preparation, presentation of the oral or poster, or any costs associated with attendance at the Conference.
- All abstracts are reviewed by members of the Committee. The Committee's decision is final.
- By submitting your abstract, you agree to have your abstract (if accepted) published on the Conference website, Conference app and in printed material.
- If you have any commercial interests or associations that might pose a conflict of interest regarding the submission, they must be declared. If accepted for presentation, the commercial interest or association must be declared on the title slide or the slide immediately following the title slide.
- You give Stormwater Australia and Think Business Events permission to film or photograph your presentation at the Conference.

# **Online Submission Instructions**

Abstracts must be submitted via the online abstract submission portal.

The online form will require you to submit your abstract in two parts:

- Register as a user and then add authors/presenters.
- submit the abstract information by completing the fields.


# STEP 1: Log in or create a profile

To get started, please select the 'log in' button at the top corner of the screen. Here you will be asked to log in with an existing profile, or to create a profile, click on 'Need to create a new account?'

This will prompt you to enter your *First name, Last name, Email address* and *create a password* for your account. Once complete click on the '**Create**' button.

You will then be taken into the portal where you may submit and withdraw any of your submission(s).

# **STEP 2: Authors**

Confirm the following items for your submission.

# a) Author details

You are required to enter the contact details of the submitting author. Please enter the name, affiliations and mobile for ALL additional authors.

# b) Add Co-Author Details

Please enter any co-author details if necessary.

# c) Who will be presenting the paper?

Please enter the full name of the author presenting the paper.

#### **STEP 3: Submit Abstract**

You will be required to fill in the following fields of the submission form.

# a) Submission Title

The title should be as brief as possible but long enough to clearly indicate the nature of the submission. Title must be in sentence case.

# b) Abstract

The abstract should not repeat the title, authors and affiliations. Max 400 words

# c) Presentation Type

Oral, Poster or either.

# d) **Theme**

- If third party material is used in the submission, I promise it does not and will not breach any existing Intellectual Property or a third party's Intellectual Property or Moral Rights.
- I give permission on behalf of all presenters and affiliations associated with the abstract submission, for the Abstract and PowerPoint to appear on the SET 2024 Conference website, Conference phone app, and in printed Conference material if it is accepted for presentation.
- You give Stormwater Australia and Think Business Events permission to film or photograph your presentation at the Conference.

# **PLEASE NOTE:**

**References** are not to be included in the abstract.

**Special Symbols and Formatting** are to be used sparingly. Once your submission is complete, please read your abstract in full to ensure the symbols are displayed correctly. If not, please click on the 'Special Character' icon on the screen to see the list of available characters to insert.

#### **STEP 4: Summary**

Once the submission form is complete you will be taken to a summary page to review all the details you have entered.





If you are happy with the information, you may then click on the submit button at the bottom of the page. The next screen will confirm your submission has been received.

You will be sent a confirmation email with your submission confirmation number.

# **Updating an abstract**

Authors may login to edit/update the submission until the call for abstracts closes on 23 April, 2024. This can be done by logging in as a RETURNING USER and selecting Edit Abstract.

# Withdrawing an abstract

If you would like to withdraw your submission, please log into the portal and click on 'My submissions'.

A 'Withdraw' button can be found next to your submission. Once you confirm, your paper will be withdrawn from being reviewed. This will also remove it from your portal.
